- 20. Agricultural. The Board approved the rezoning of 2 lots to R-2 Low Density Residential Now a party wants to buy both lots and have the zoning changed to R-1 Rural residential and combine the lots to make a 3.98-acre parcel split from the 34.6 acres. The original split was never completed.
- 21. Request by David W. Coleman and Roxanna L. Pelow 8464 Brown Street. Ottawa Lake Mi. 49267 regarding parcel # 5815-019-048-00 Parcel contains .997 acres and is zoned B-1 Local Business to R-3 Medium Density Residential. Family was not aware of the zoning when they bought it.
- 22. Requested by Caroline Kibler Trust (Edward Kibler Trustee) regarding parcel # 5815-012-106-00 located AT 4318 West Erie Road, Temperance MI. 48182. Parcel contains 20 acres and is zoned AG. Agricultural. Appellant is requesting a zoning change from AG to R-1 Rural Residential in order to split a 2-acre parcel containing the house and accessory buildings.
- 23. Road Report: Monroe County Road Commission has gotten a "Grant" for the left turn lanes both East and West on Sterns road at Whiteford Center. And the left turn lane off Sterns to Whiteford Road south and the left turn lane on Whiteford road at Sterns. The total cost is about \$800,000 and it has a 20% match which = \$160,000. The Hicker Bridge Grant is 5% plus engineering, so the Total cost is \$95,000. We want to widen Jeffs Road from Sterns to Jeffs Doty then one lift of asphalt to Consear and that is about \$235,000. I would like to complete the paving in Whiteford Township with putting one lift of hot mix on County Line Road from Railroad to US 223. That will be about \$250,000. We could do one bond in the neighborhood of \$800,000 for all that work and it's first payment would be an interest payment in January 2023 and a principal payment in August. The Clark Road Bond last payment is August of 2022. The overpass work on Sterns Road is tentatively scheduled for 2023. MDOT is also planning on doing the overpass at Consear in the same year.
