- 11. BUILDING INSPECTOR PAY INCREASE: Todd Roach, Building Inspector has requested an increase in the annual salary from \$15,600 to \$16,000 and the hourly rate for meetings from \$40/ hour to \$45/hour. The annual salary is for plan review of building permits.
- 12. GAMING LICENSE: Approve Resolution for a Gaming License for the Whiteford School Music Boosters to hold 50-50 raffles.
- 13. OFFICE WORK STATION: Approval to purchase an office work station for the Clerk Assistant to give her amble area to work.
- 14. HIGHLAND TREATMENT: Highland Treatment is raising their rates from \$888 per month to \$916 per month for the monthly operational base for wastewater services. Approval to continuing using Highland Treatment to monitor Sewer I and Sewer II
- 15. ELECTION INSPECTOR TRAINING STIPEND: The \$15 training stipend for election inspectors has not changed for many years. They are now required to travel to Monroe for training. The new stipend is proposed at a minimum of \$30 but more accurately would be \$45 to compensate for travel and training time.
- 16. HEALTH INSURANCE: discussion on how to handle the increased cost.
- 17. FALL FESTIVAL COMMITTEE: Cassidy Sloan and Ron Miller will be presenting proposed play equipment at Whiteford Stoneco Park.
- 18. FIRE: Approval of "Substance Abuse Policy for the Whiteford Township Fire Department as presented.
- 19. FIRE: discussion on proposed compensation for volunteer firefighters.
